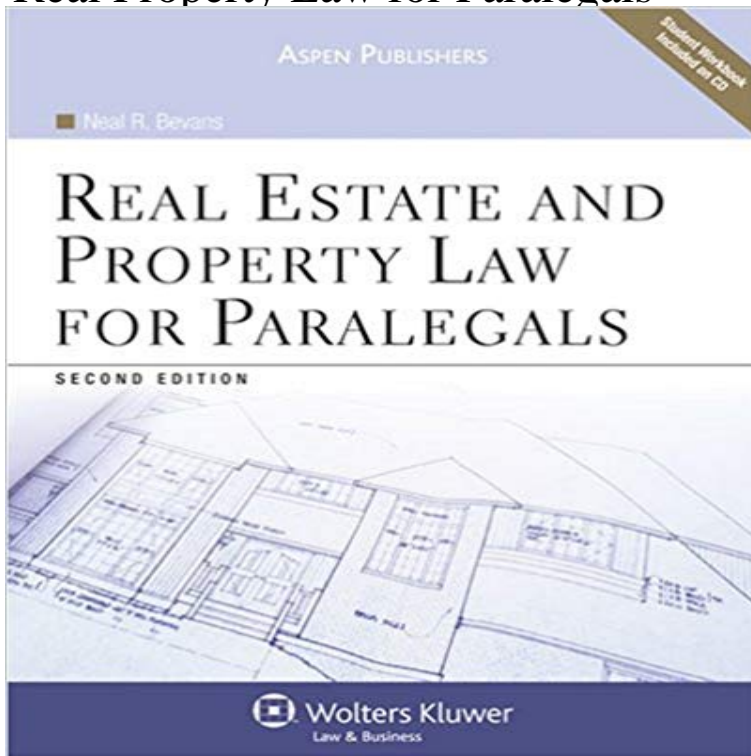


# Real Property Law for Paralegals
