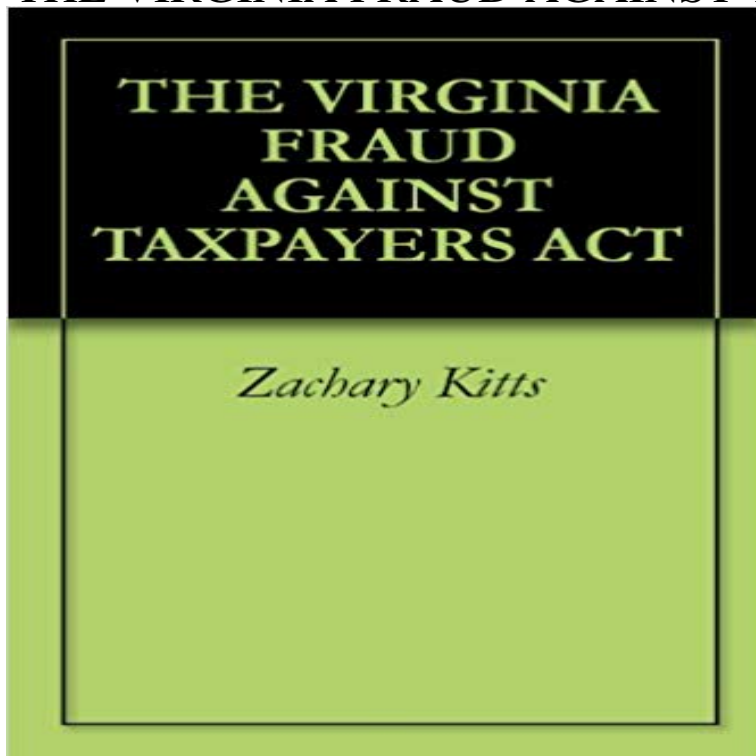


# THE VIRGINIA FRAUD AGAINST TAXPAYERS ACT
