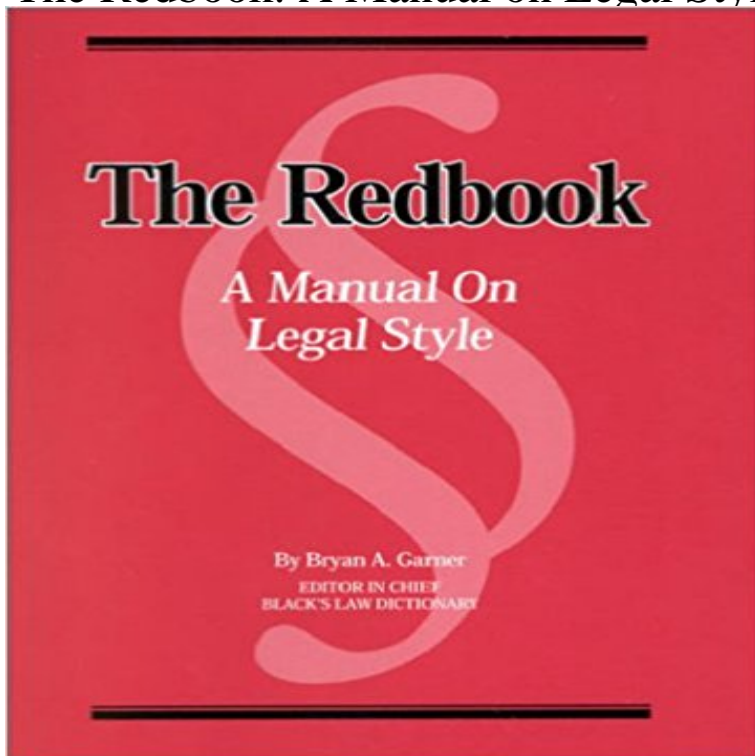


The Redbook: A Manual on Legal Style
