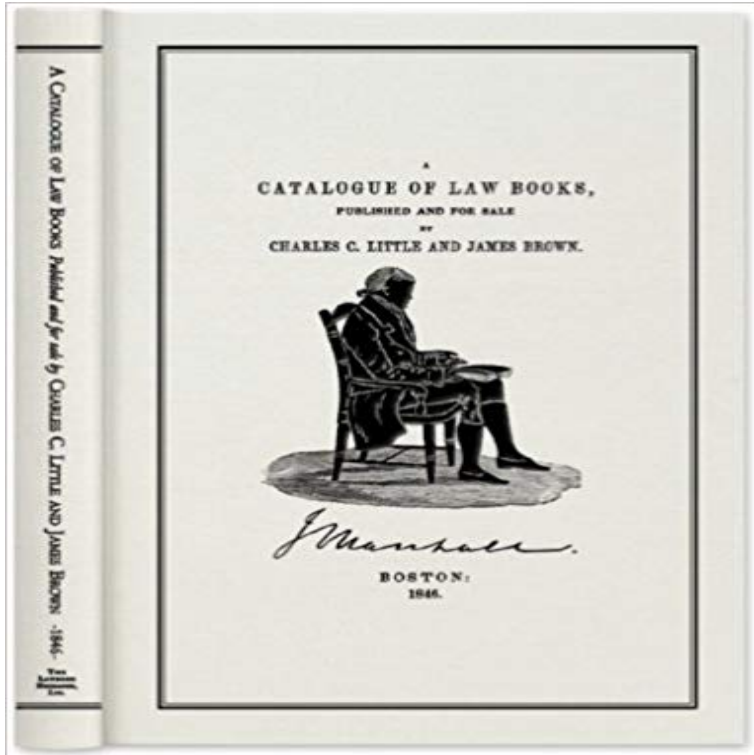

Another interesting feature is a section by Joseph Greenleaf entitled Catalogue of a Select Law Library that lists the Books which are useful to every American Lawyer, in whatever State he may reside (xxx-xl). Based on the Harvard Law School reading list, the titles are arranged by subject in parallel columns. Essential titles are in listed in one column, useful, but supplemental, titles in the other. It also includes an advertisement for Harvard Law School that describes its philosophy, curriculum and fees.
