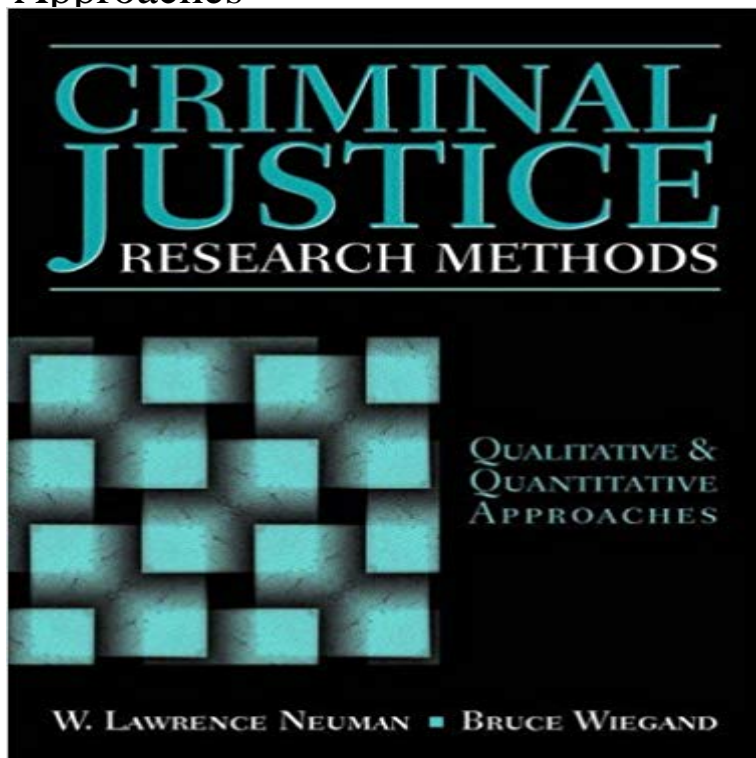


# Criminal Justice Research Methods: Qualitative and Quantitative Approaches
