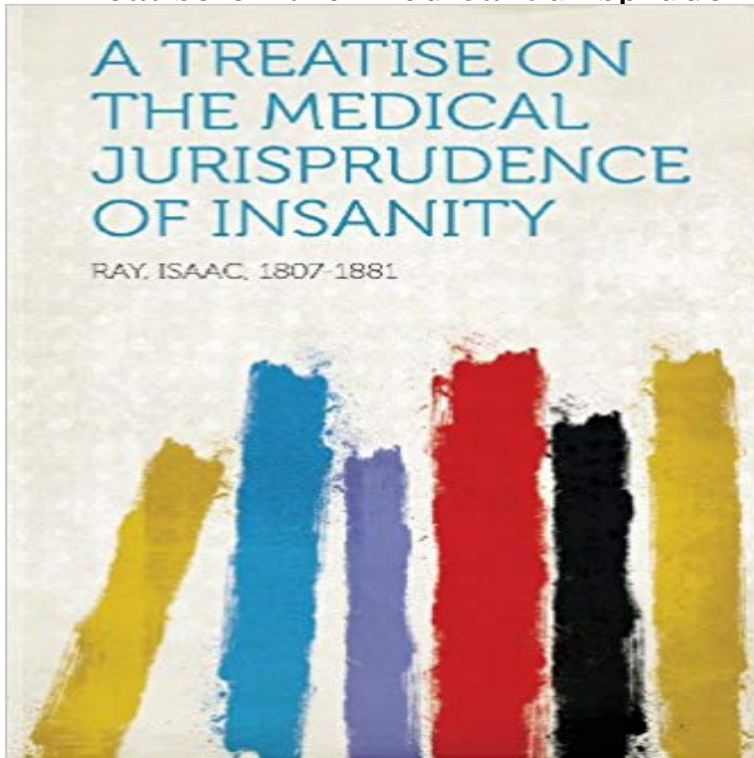


A Treatise on the Medical Jurisprudence of Insanity
