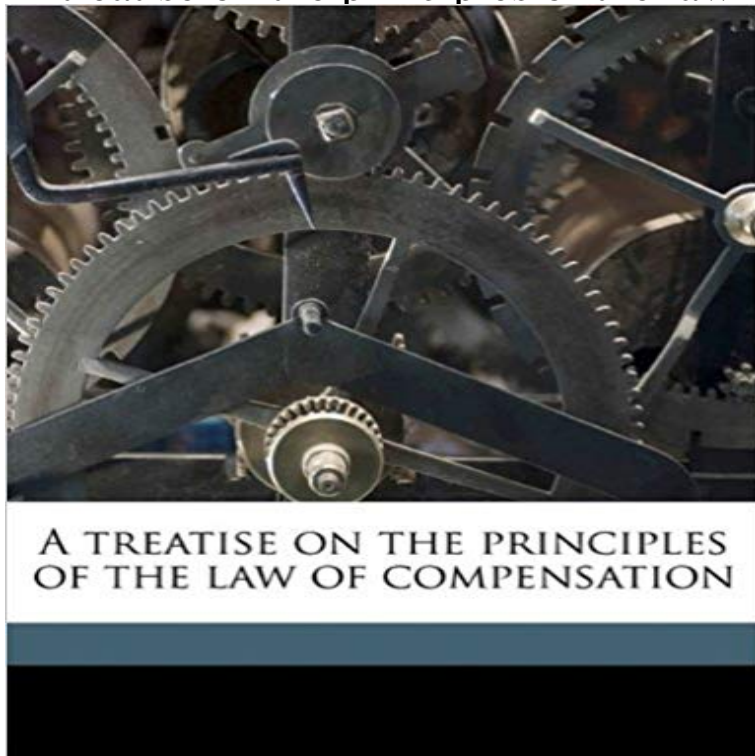


## A treatise on the principles of the law of compensation
