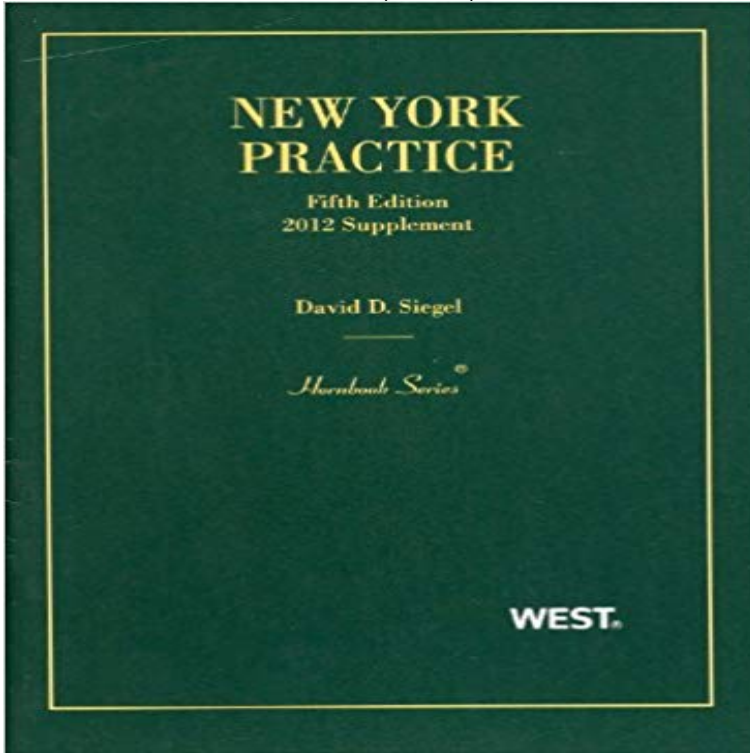


## New York Practice, 5th, Student Edition, 2012 Supplement (Hornbook)

To eliminate the gap between what a student learns in law school and what a new lawyer actually needs to know in practice, the book starts from scratch on subjects, rather than assuming knowledge. This time-saving reference guide contains a Westlaw appendix; expert commentary; footnote citations to leading court decisions; and tables of cases, statutes and court rules.
