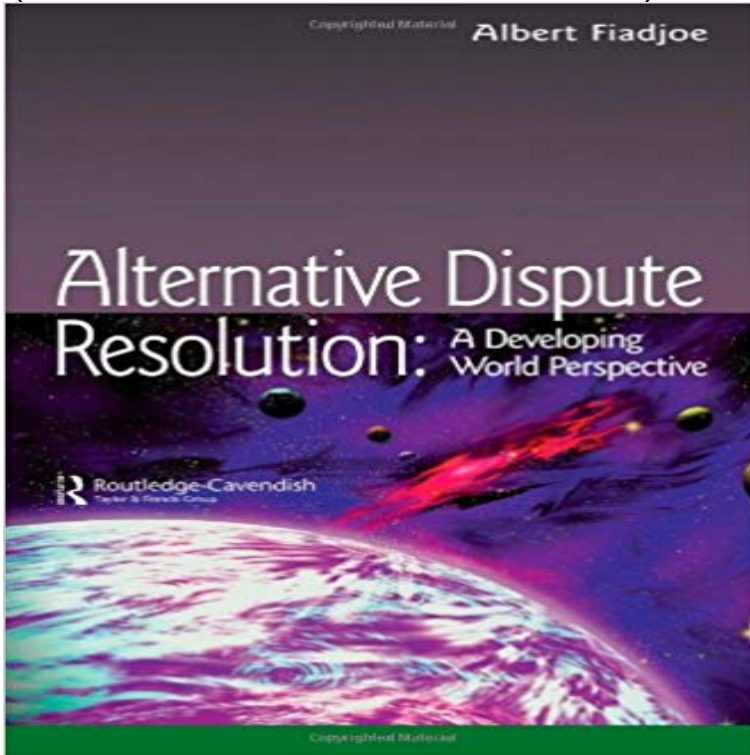


Alternative Dispute Resolution: A Developing World Perspective (Commonwealth Caribbean Law)
