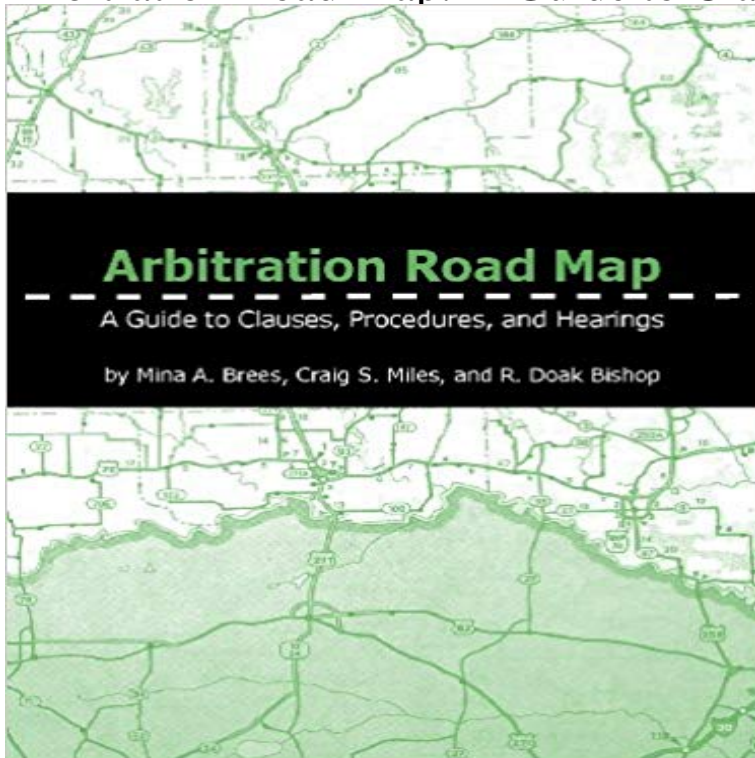


Arbitration Road Map: A Guide to Clauses, Proceedings, and Hearings
