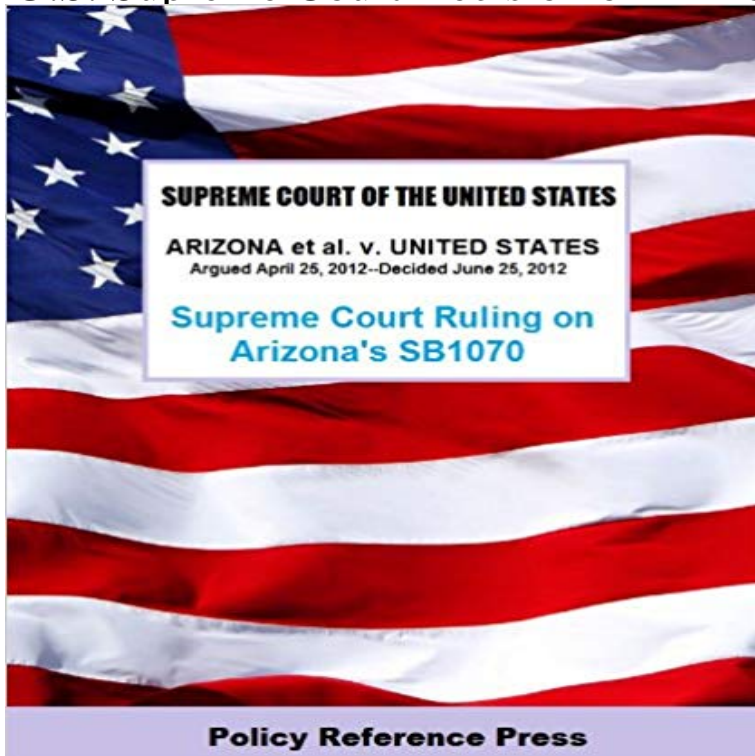


## U.S. Supreme Court Decision on Arizonas SB 1070 (6/25/2012)
