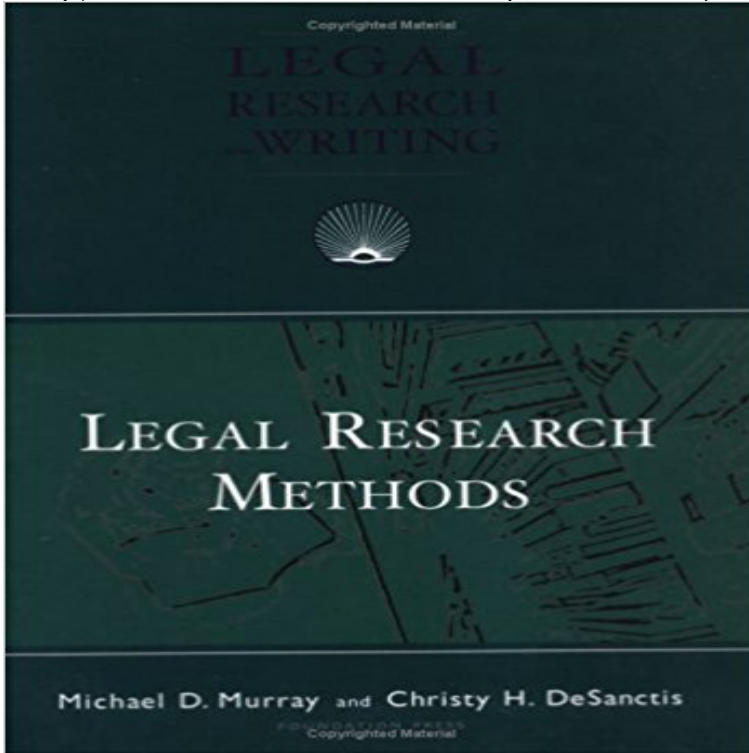


Legal Research Methods (University Casebook Series)
