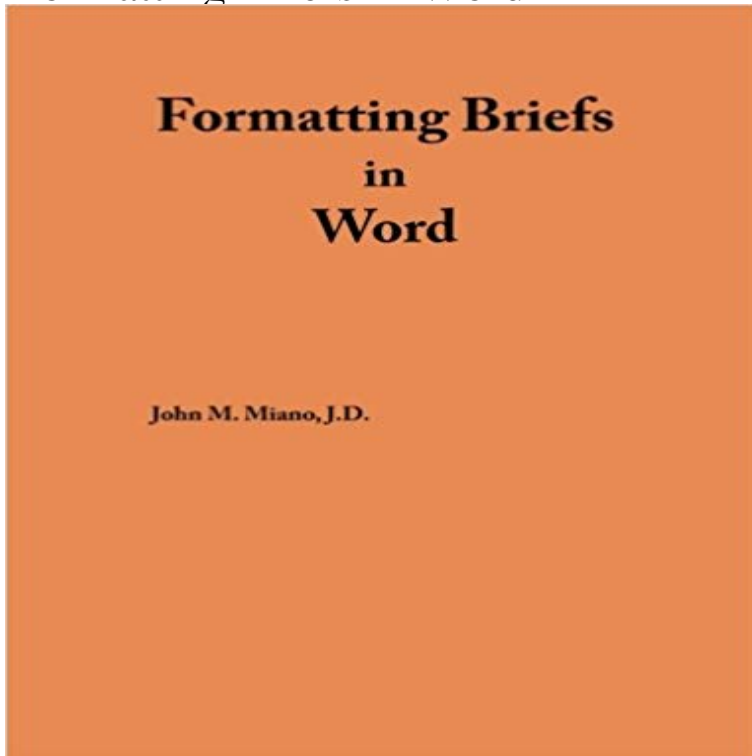


Formatting Briefs in Word
