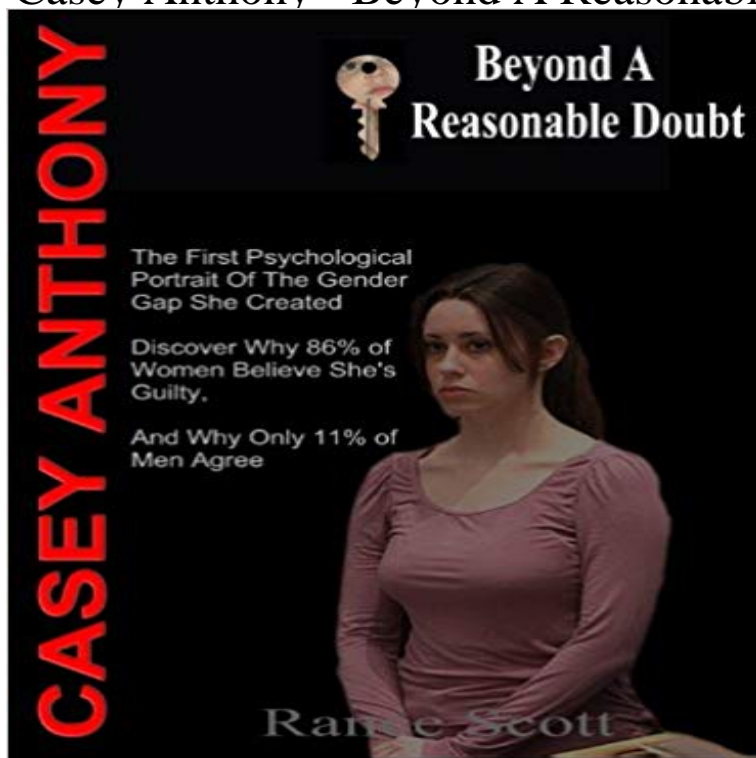


## Casey Anthony - Beyond A Reasonable Doubt
