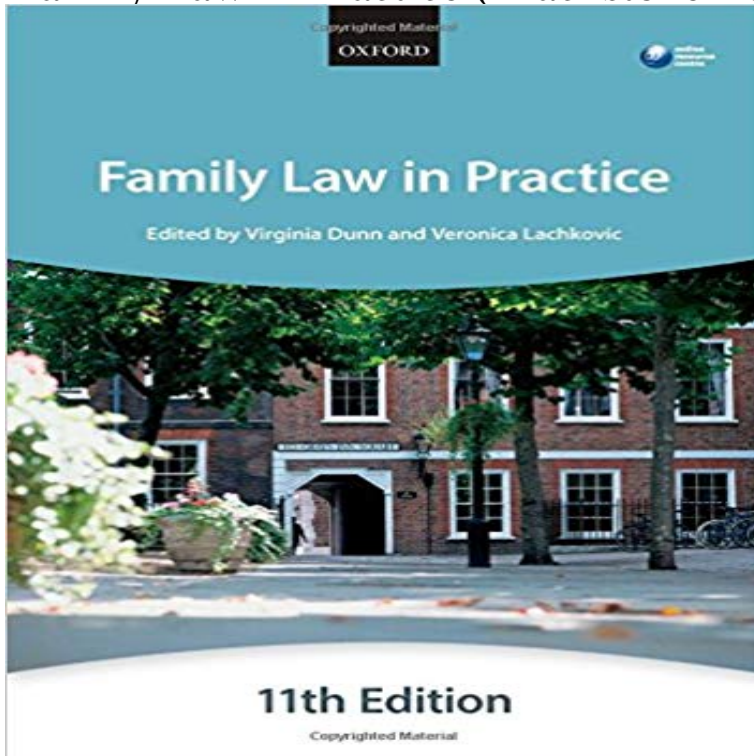


## Family Law in Practice (Blackstone Bar Manual)
