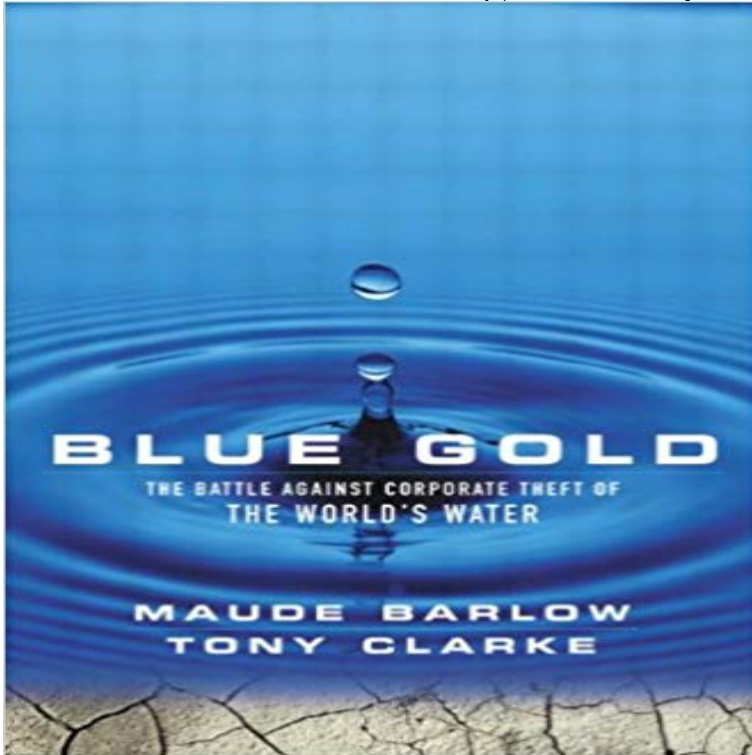


Blue Gold: The Battle Against Corporate Theft of the Worlds Water
