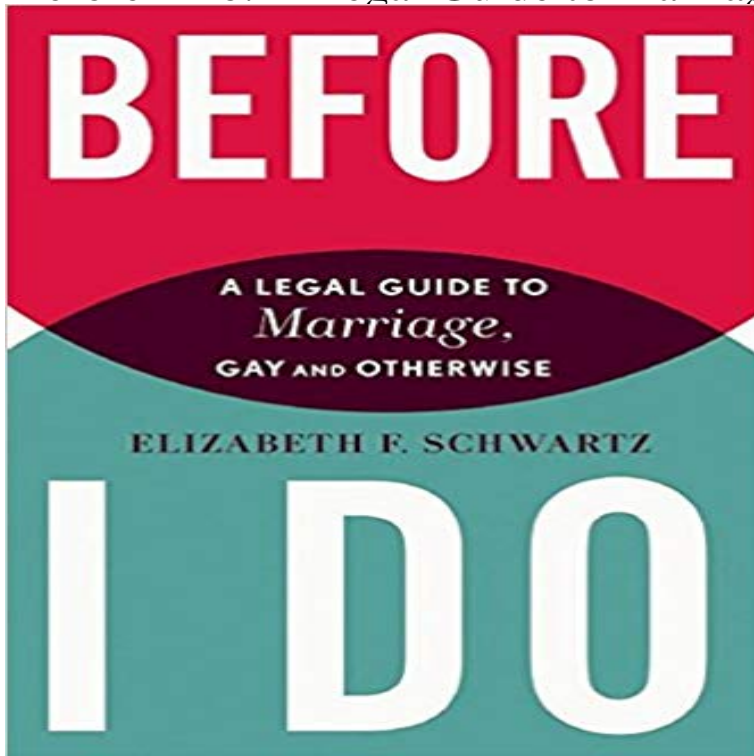


## Before I Do: A Legal Guide to Marriage, Gay and Otherwise
