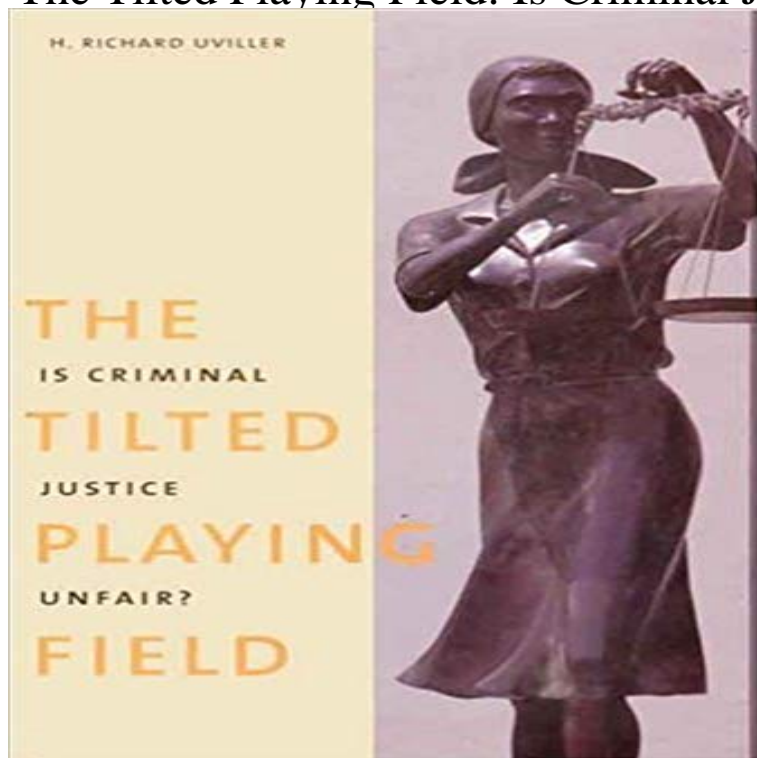


## The Tilted Playing Field: Is Criminal Justice Unfair?
