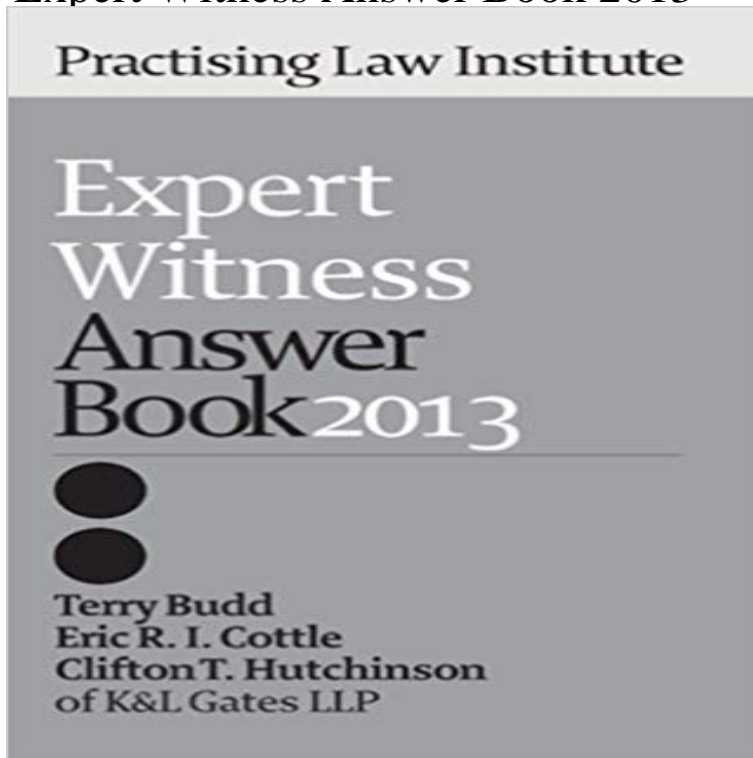


## Expert Witness Answer Book 2013
