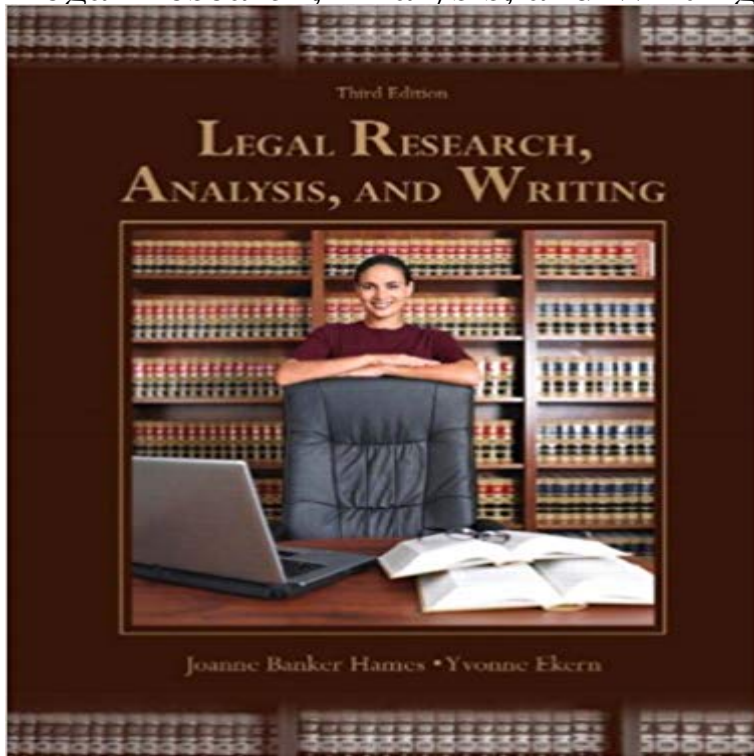


## Legal Research, Analysis, and Writing (3rd Edition)
