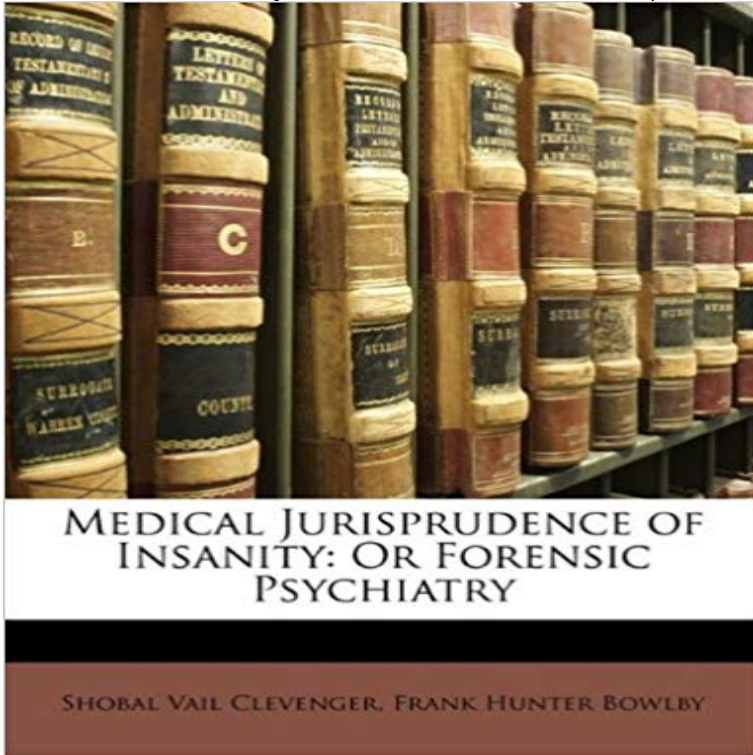


Medical Jurisprudence of Insanity: Or Forensic Psychiatry
