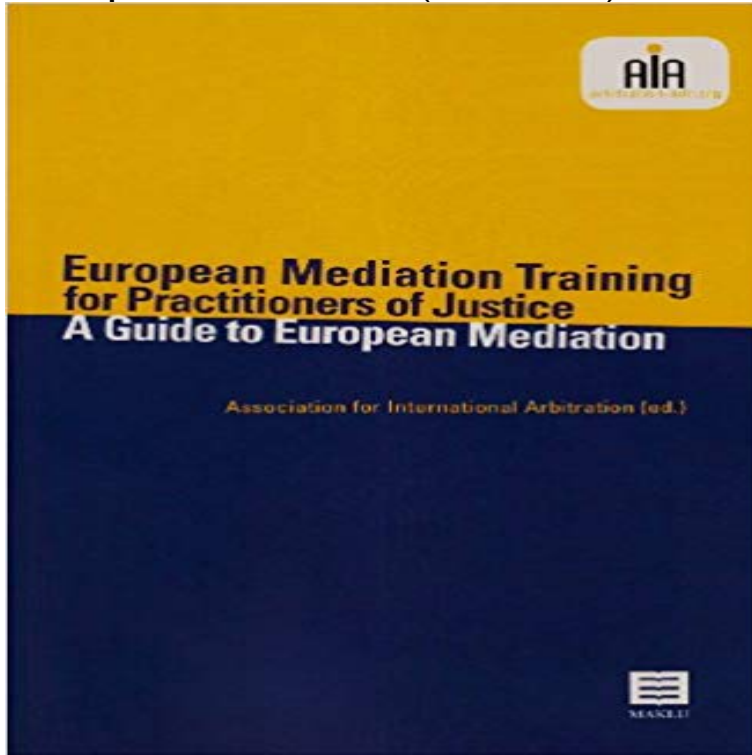


European Mediation Training for Practitioners of Justice. A Guide to European Mediation (incl. dvd)
