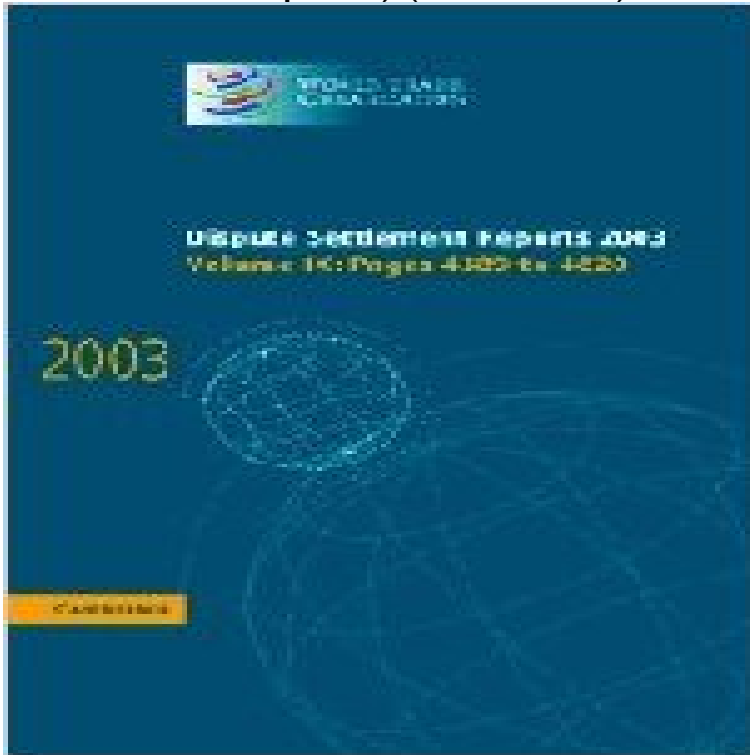


## Dispute Settlement Reports 2003 (World Trade Organization Dispute Settlement Reports) (Volume 9)
