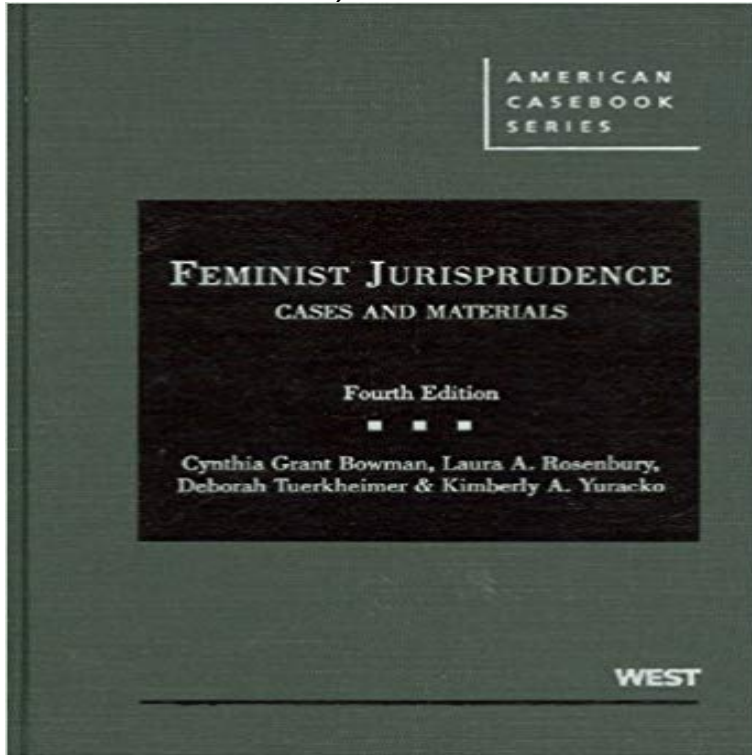


Feminist Jurisprudence: Cases and Materials, 4th Edition (American Casebook Series)
