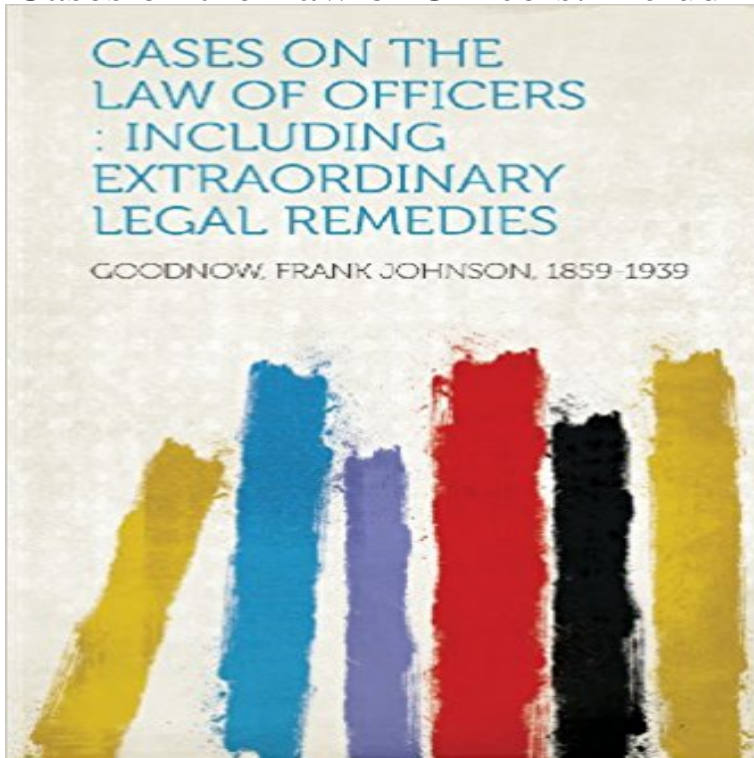


# Cases on the Law of Officers: Including Extraordinary Legal Remedies
