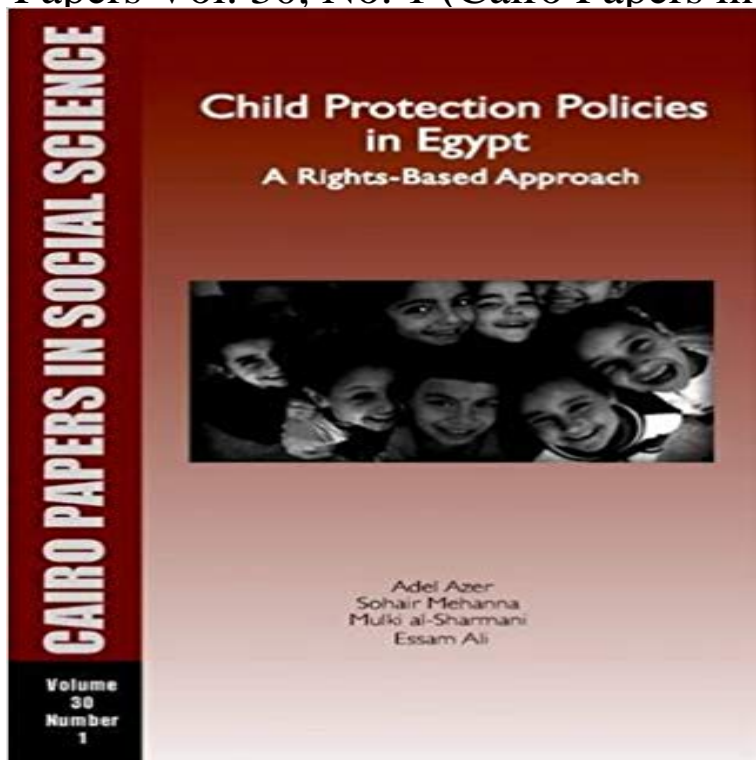


Child Protection Policies in Egypt: A Rights-Based Approach: Cairo Papers Vol. 30, No. 1 (Cairo Papers in Social Science)

It identifies the ways in which these policies fail to link child rights and child protection and thus are unable to provide integrated and accessible services that meet childrens needs.
