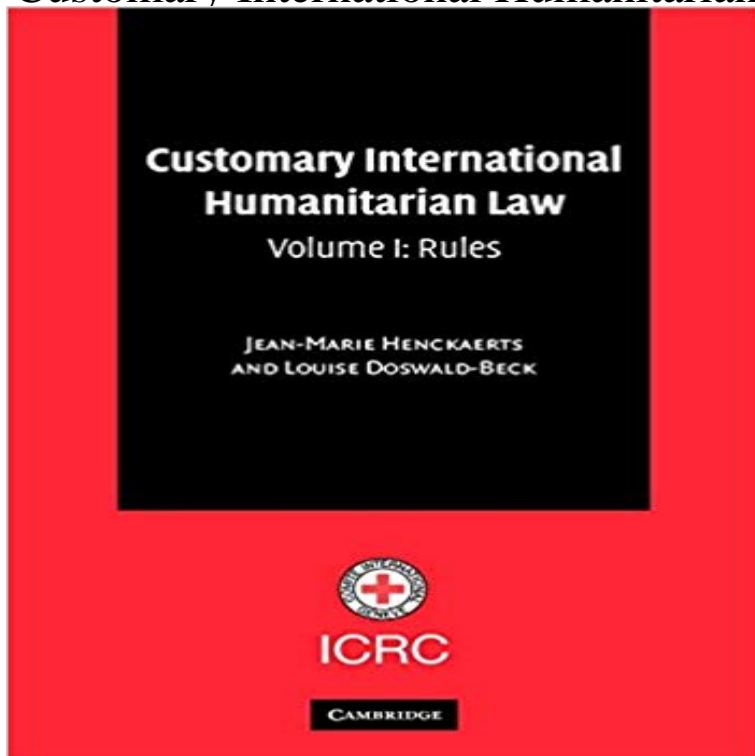


## Customary International Humanitarian Law: Volume 1, Rules
