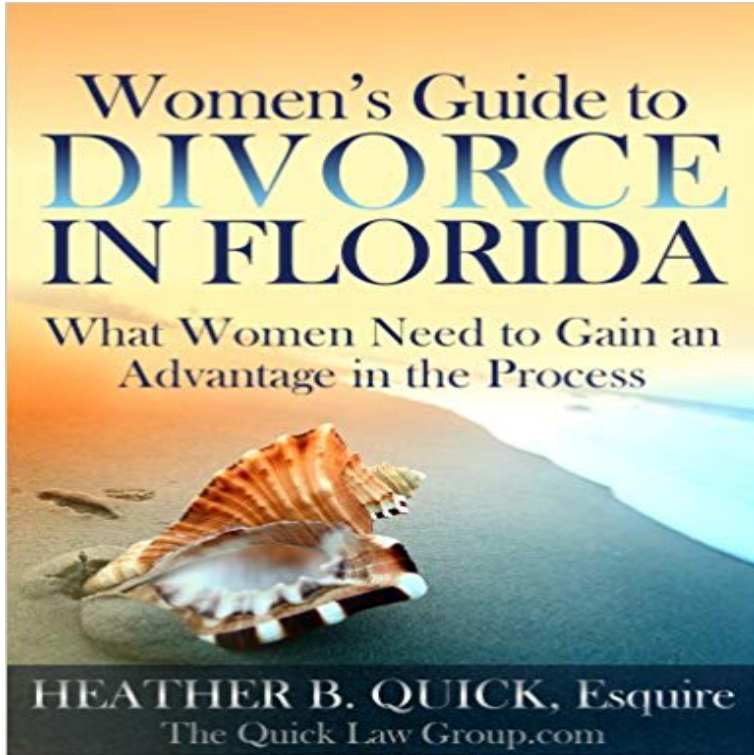


## A Womans Guide to Getting Divorced in Florida: 15 Key Strategies: What Women Need to Gain an Advantage in the Process
