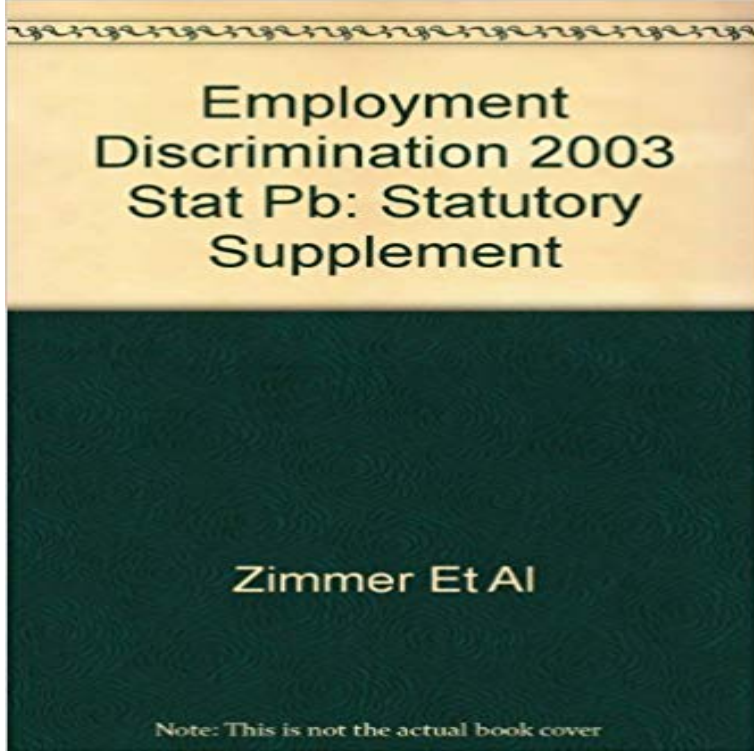


## Employment Discrimination, 2003 Statutory Supplement
