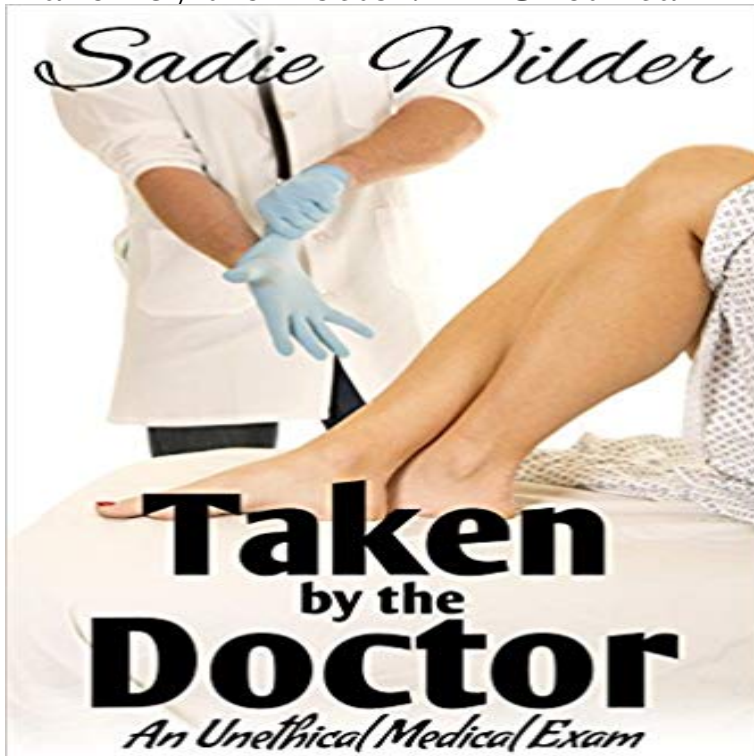


Taken by the Doctor: An Unethical Medical Exam
