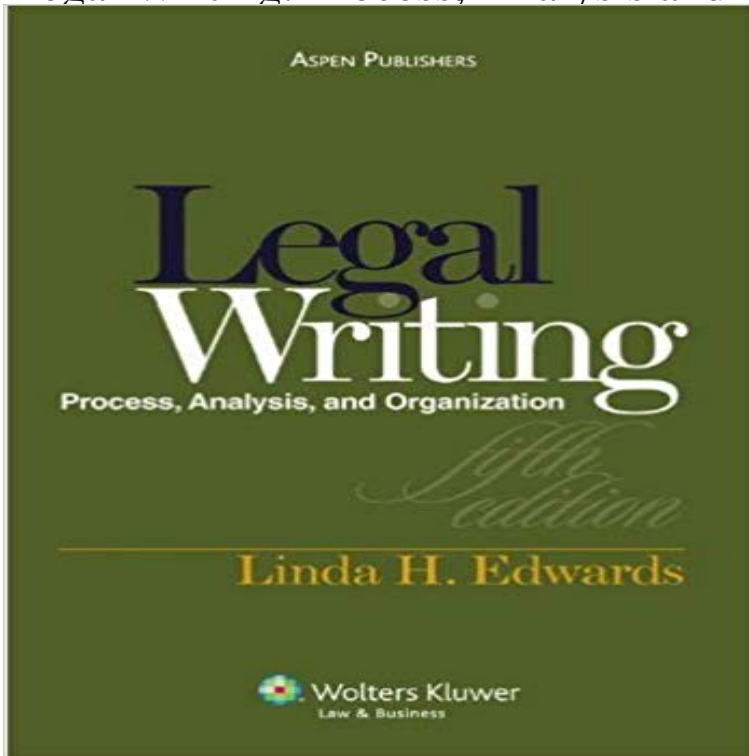


# Legal Writing: Process, Analysis and Organization, 5th Edition
