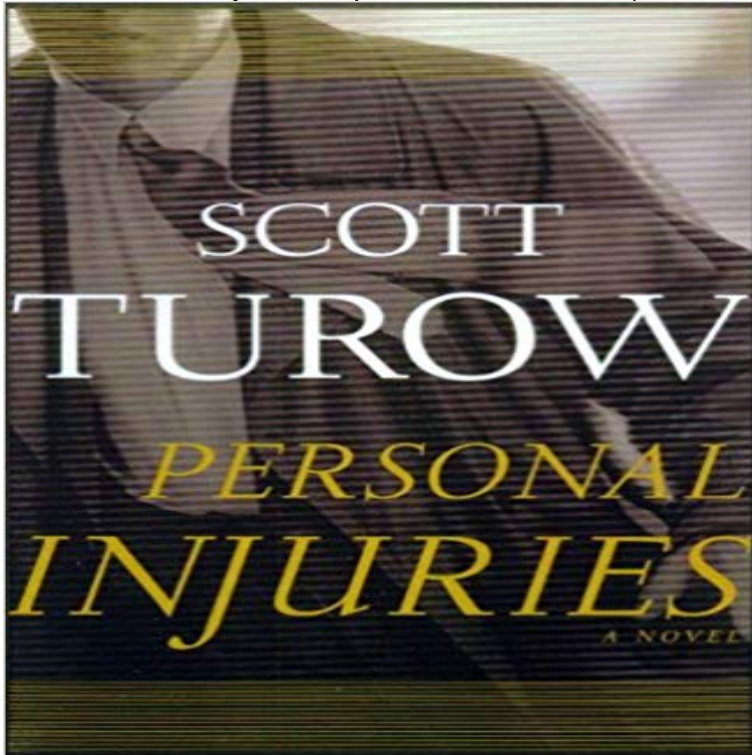


## Personal Injuries (Kindle County Book 5)
