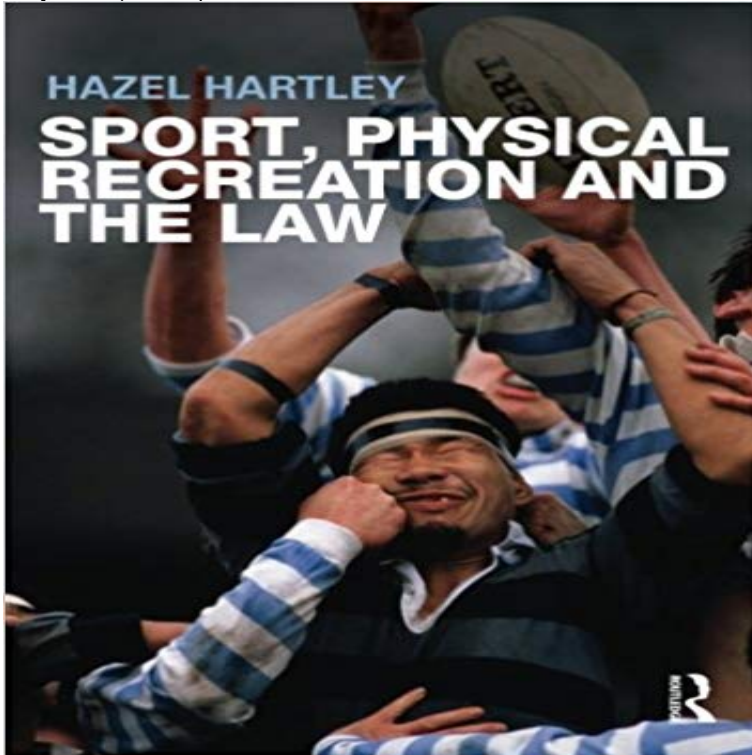


## Sport, Physical Recreation and The Law
