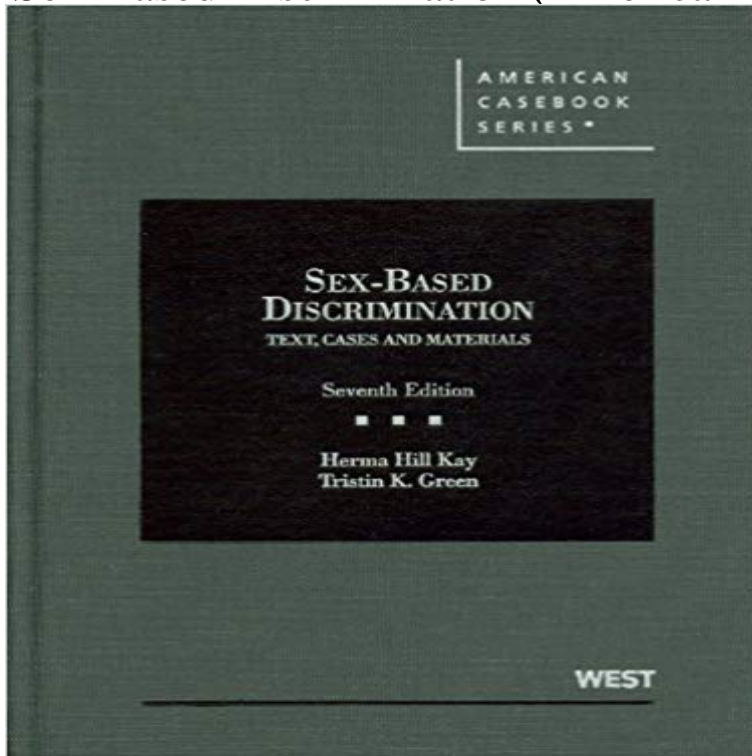


Sex-Based Discrimination (American Casebook Series)
