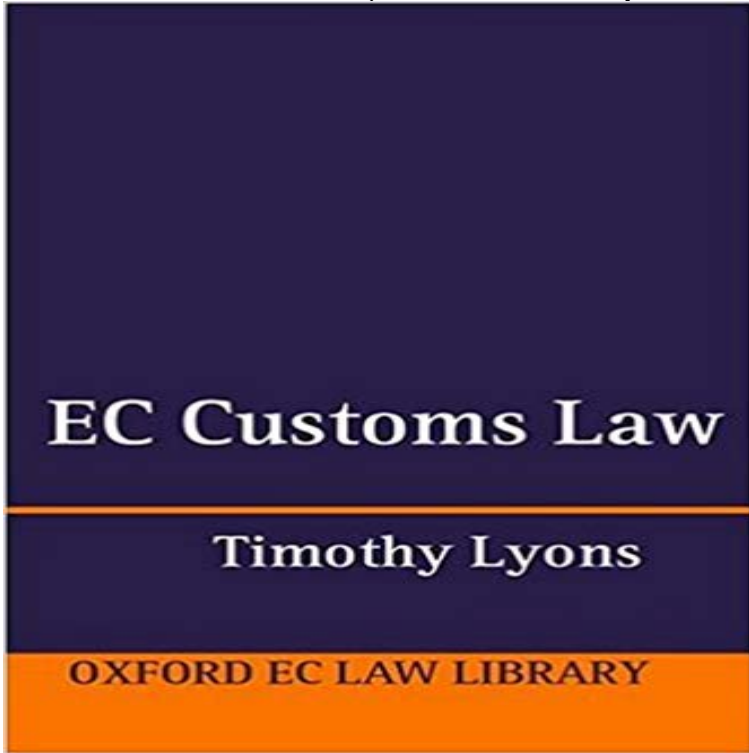


EC Customs Law (Oxford European Community Law Library)
