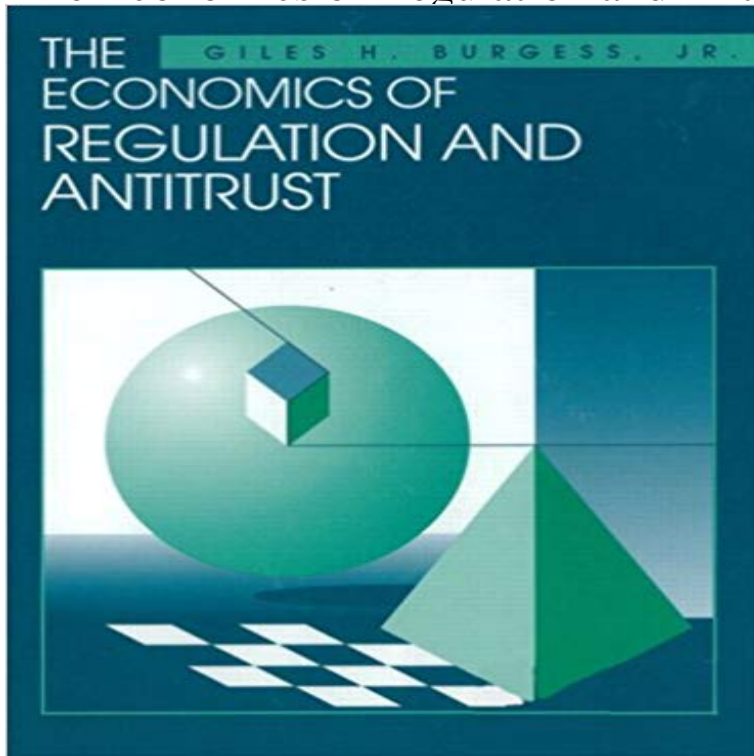


# The Economics of Regulation and Antitrust
