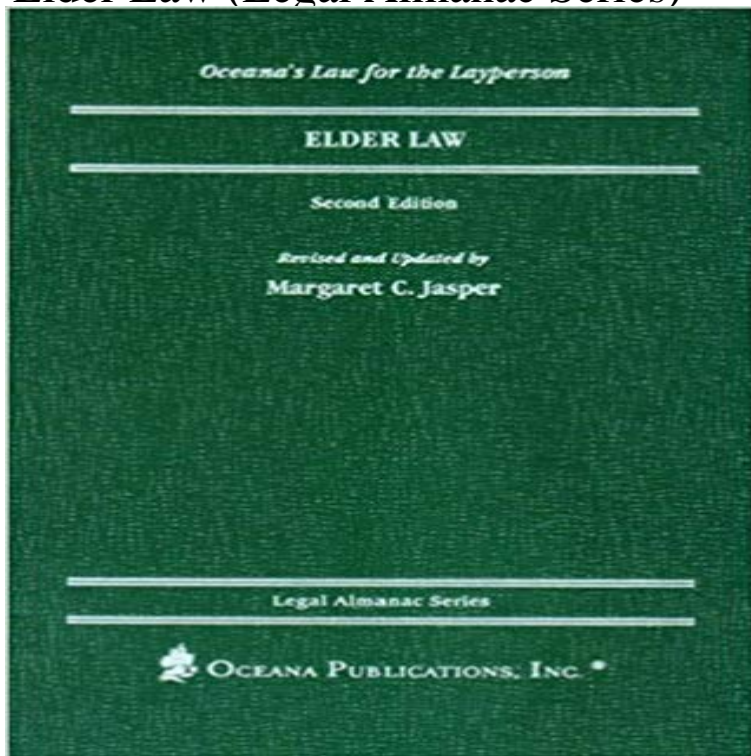


Elder Law (Legal Almanac Series)
