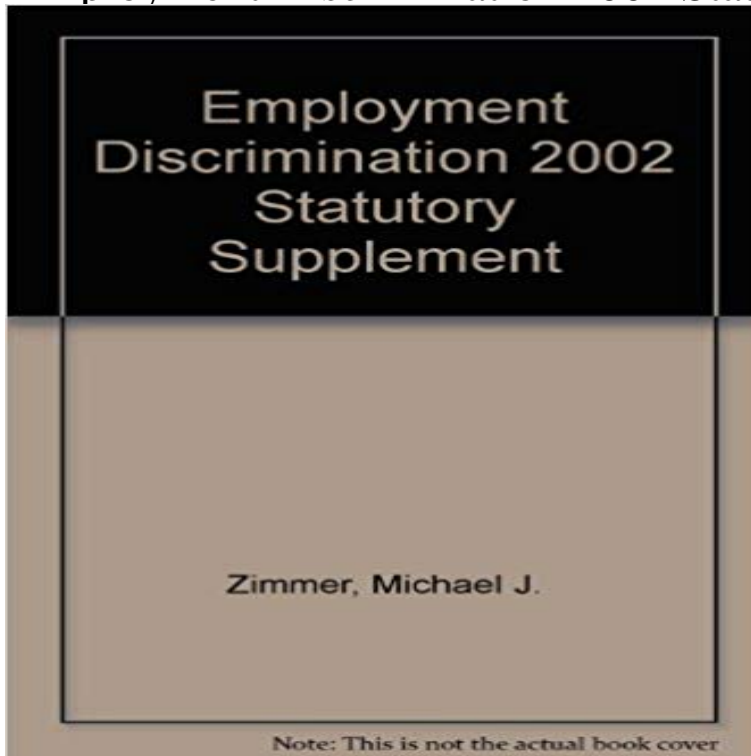


Employment Discrimination 2002 Statutory Supplement
