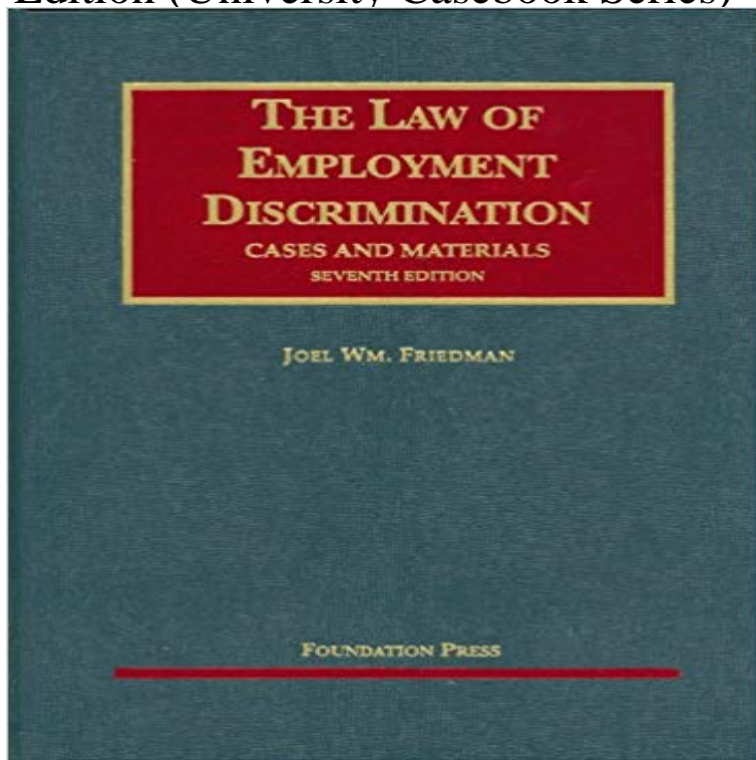


## Cases and Materials on The Law of Employment Discrimination, 7th Edition (University Casebook Series)
