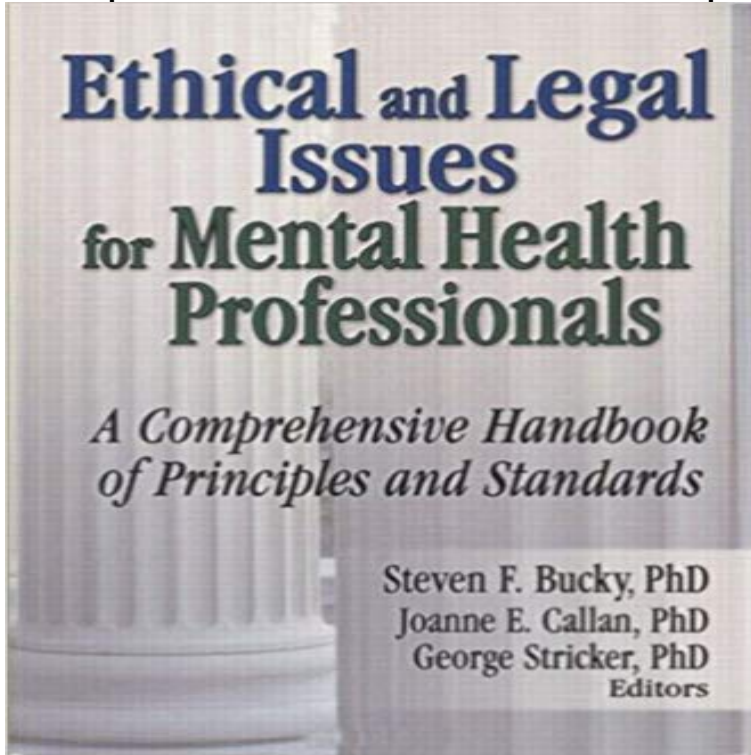


# Ethical and Legal Issues for Mental Health Professionals: A Comprehensive Handbook of Principles and Standards
