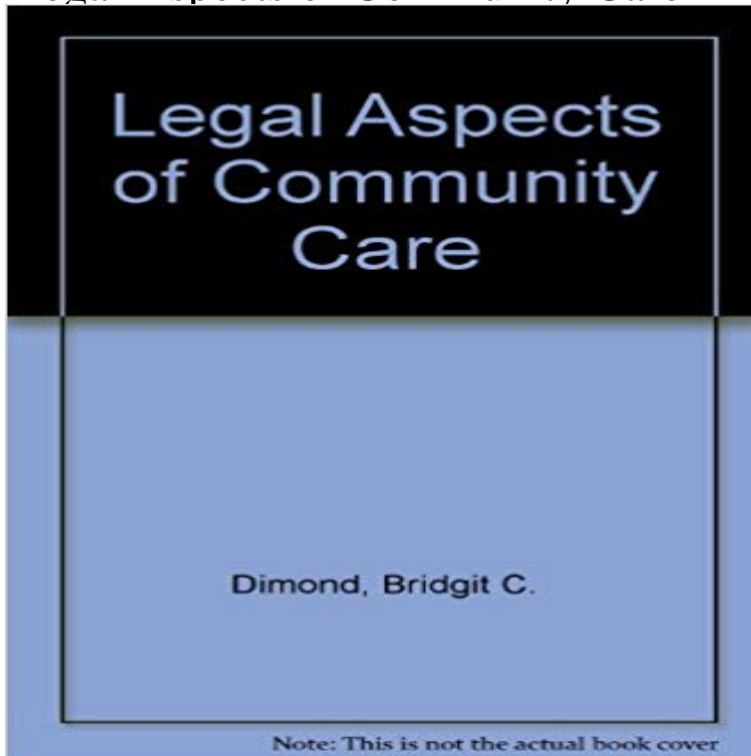


## Legal Aspects of Community Care
