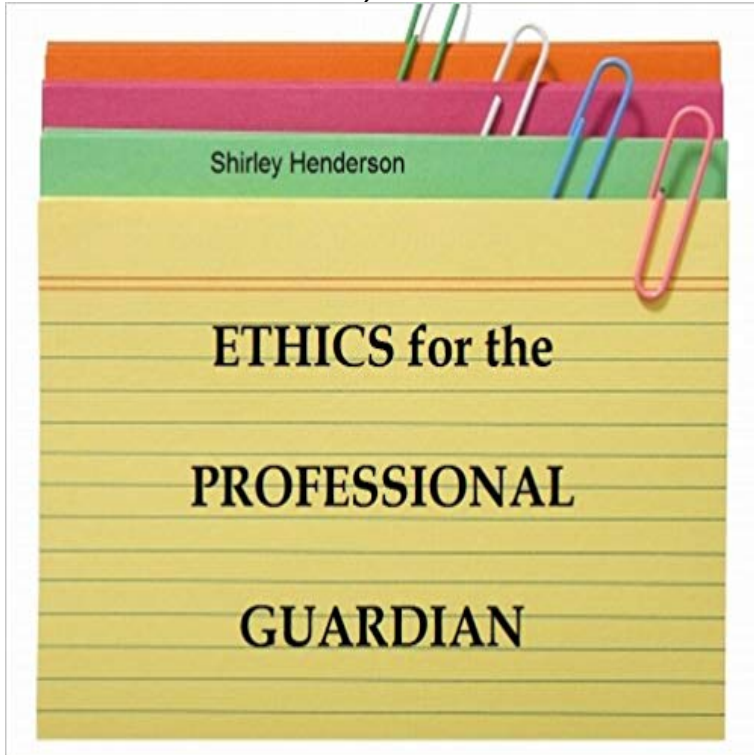


# Ethics and the Professional Guardian (Professional Guardian Continuing Education Book 1)
