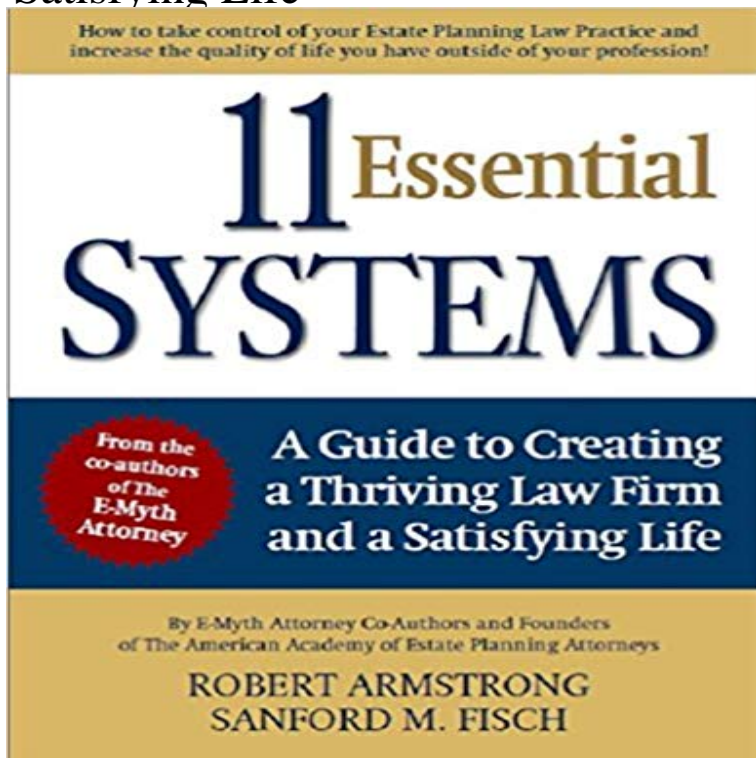


11 Essential Systems: A Guide to Creating a Thriving Law Firm and a Satisfying Life
