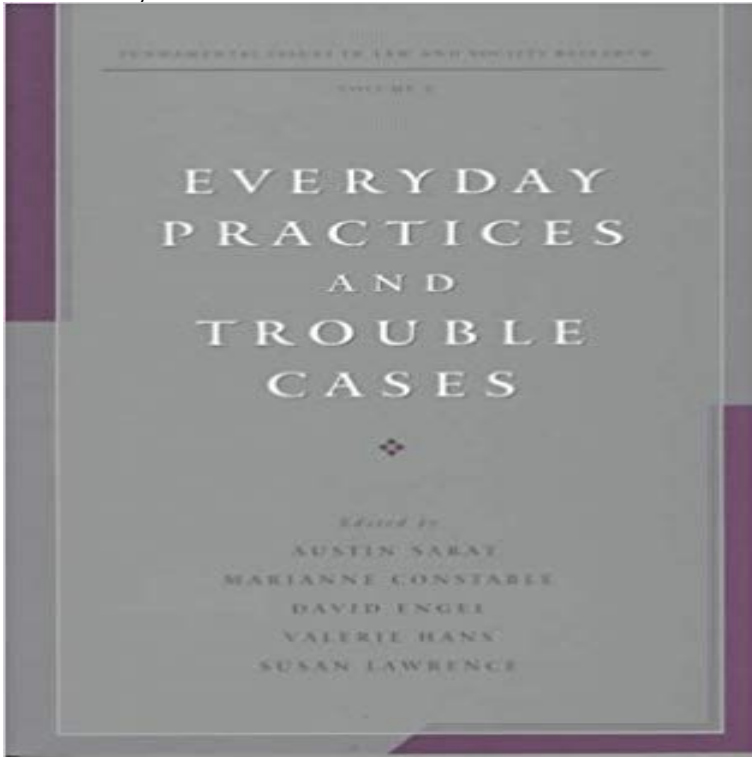


# Everyday Practices and Trouble Cases: Fundamental Issues in Law and Society Research: Volume 2
