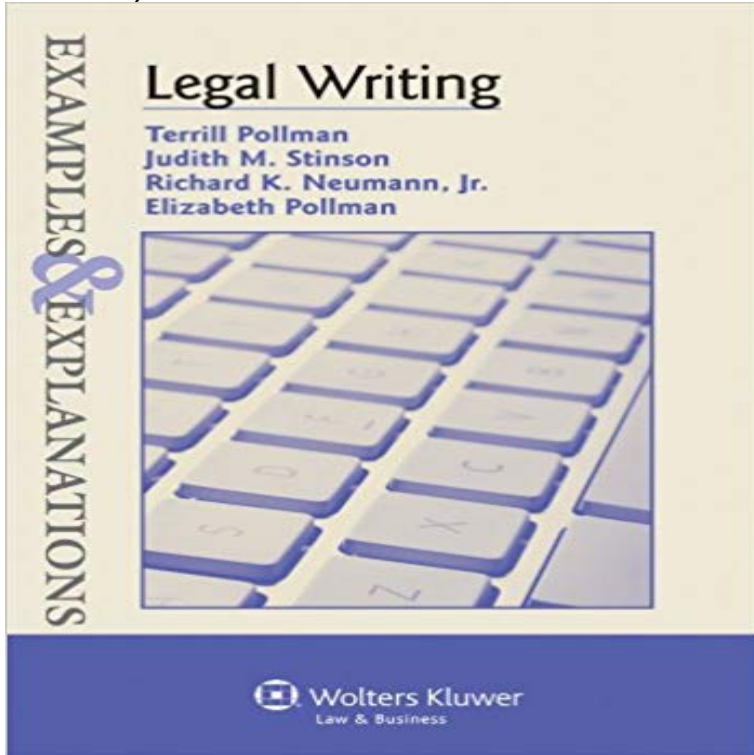


Legal Writing: Examples & Explanations (The Examples & Explanations Series)

Students decide whether the writing excerpts in the examples meet certain criteria for effectiveness. The authors then explain why the example succeeds or fails to meet those criteria. *Legal Writing: Examples & Explanations* is designed to accompany any legal writing text. Focusing on core writing skills, *Legal Writing, Examples & Explanations* features: examples that focus on each part of the memo or brief; several examples for each part; because there are many ways to write well or badly questions after each example that ask whether the writing sample satisfies certain criteria for effective writing; detailed explanations for why the example does or does not meet those criteria; pedagogically consistent chapter organization; what you need to know about the skill under discussion; a step-by-step how to section; examples; explanations; two case files; the facts and authority located in the appendices; that form the basis for most of the example; straightforward, conversational writing style.
