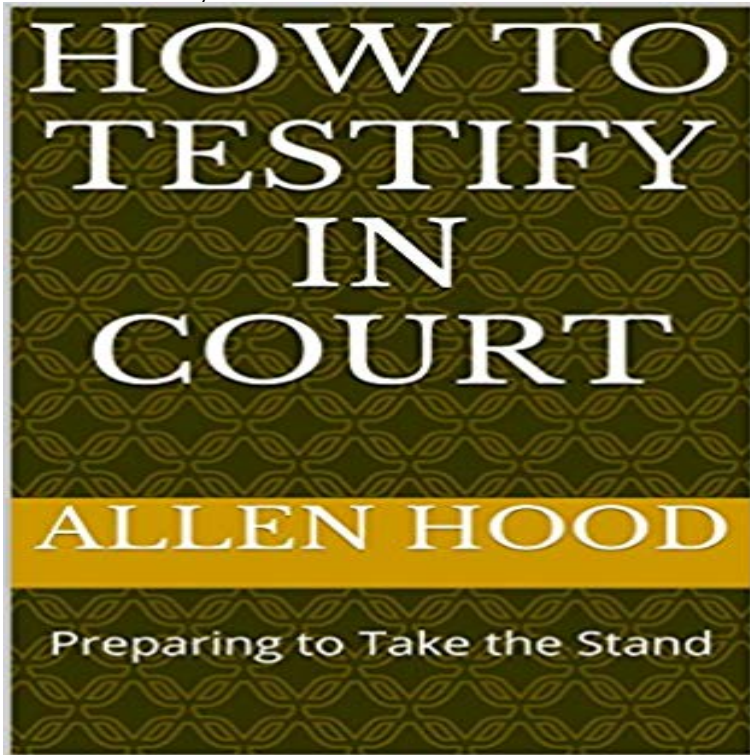


# How to Testify in Court: Preparing to Testify or Write About Legal Testimony
