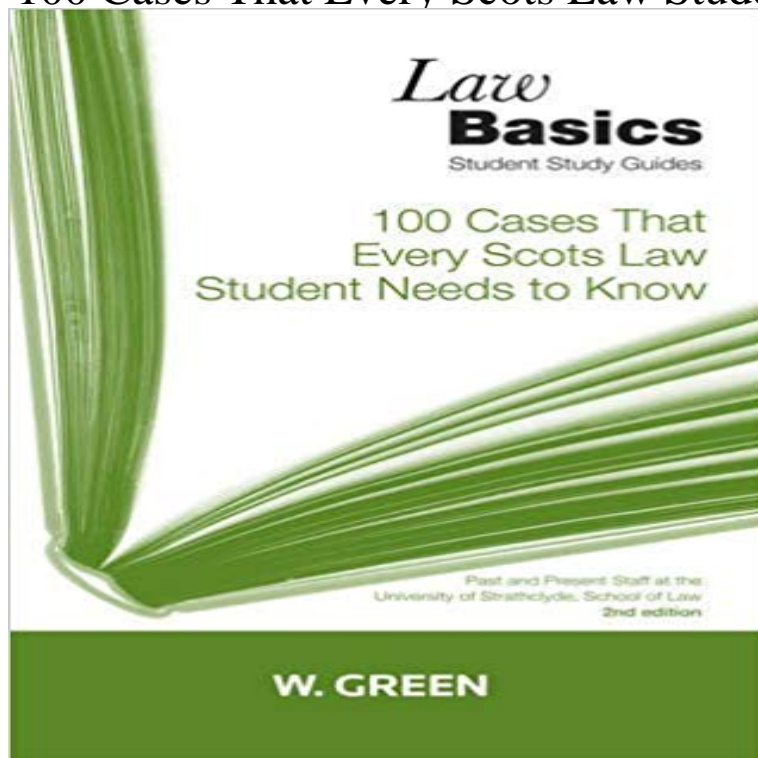


## 100 Cases That Every Scots Law Student Needs to Know (Law Basics)
