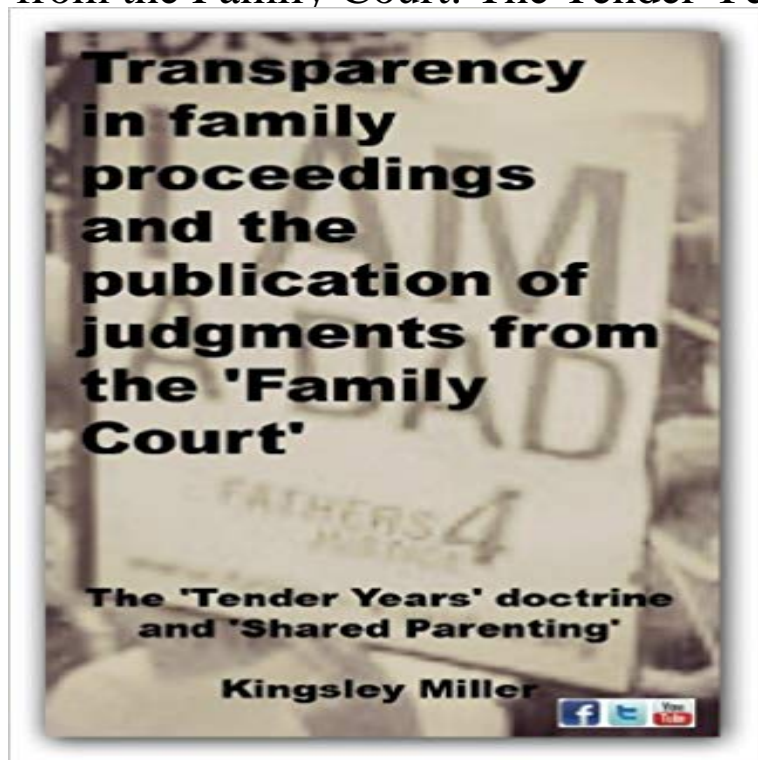


Transparency in family proceedings and the publication of judgments from the Family Court: The Tender Years doctrine and Shared Parenting



The Court of Appeal decided that given the authors history of responsible campaigning and writing on issues relating to family relationships to grant him permission to publish the County Court judgments from his family proceedings which otherwise would be a contempt punishable with imprisonment. As well as transcripts of these judgments which provide a unique insight into the operation of the UK Family Court this book includes correspondence with Professor Sir Michael Rutter, author of the seminal work Maternal Deprivation Reassessed as well as a personal letter of congratulations from a former Home Secretary.
