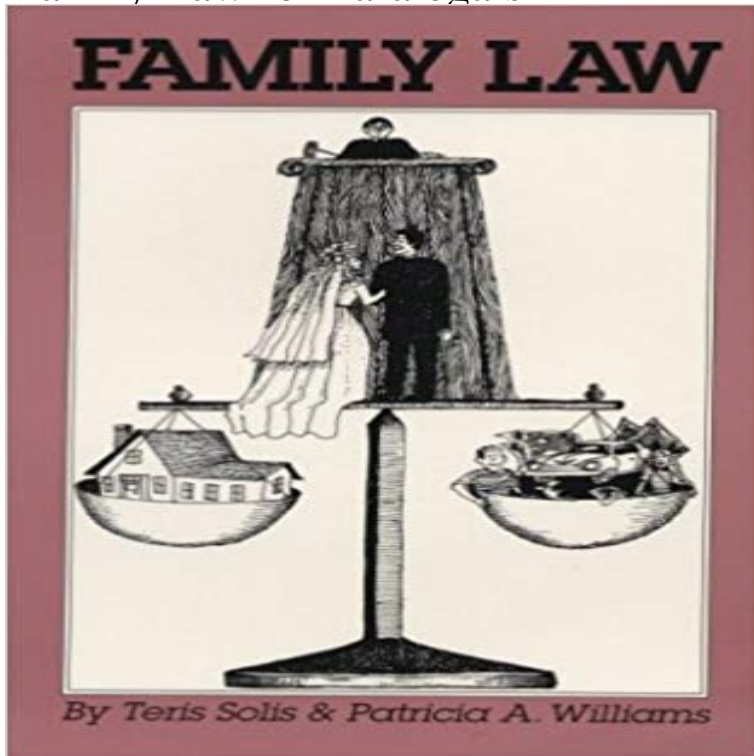


## Family Law for Paralegals
