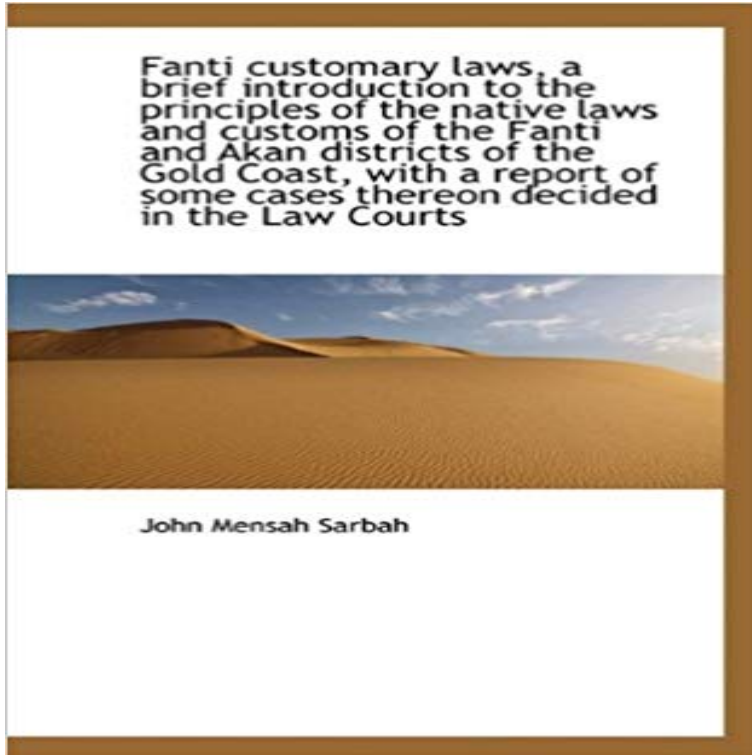


Fanti customary laws, a brief introduction to the principles of the native laws and customs of the F
